## Revocation of assets in order to prevent the Third World War and prevent the return of Nazism.


We are *guided* by previous resolutions and statements of the *International Treasury Monetary One*,

*Reaffirming* Resolution No. 1 (001/RES2020) of April 07, 2020 "On the way out of the global financial crisis", Resolution No. 2 (002/RES2020) of June 02, 2020 "The only way out of the global financial crisis", Resolution No. 4 (004/RES2021) of February 23, 2021 "Cancellation of historical assets in order to form a balanced new financial system", Resolution No. 5 of July 16, 2021 (005/RES2021), Resolution No. 6 of September 13, 2021 (006 /RES2021), Resolution No. 7 of 01 October 2021 (007/RES2021), Resolution No. 8 of December 21, 2021 (008/RES2021), Resolution No. 9 of December 22, 2021 "Reform of the global financial and economic system and its architecture" (009/RES2021), Resolution No. 11 of January 22, 2022 "On the termination of all relations with the well-known surname of financiers Rothschild" (011/RES2022), Resolution No. 12 of February 27, 2022 "Revocation of all Rights to Assets from the Trilateral Commission of the Trillenium Gold Reserve and New World Order Financial System Trusts" (012/RES2022),

International Treasury Monetary One remind that Peace, stability and prosperity are inseparable. In today's globalized economy, all nations are much more connected than ever before. The global reach of this crisis requires prompt, decisive and coordinated action to address its causes, mitigate its effects, create and strengthen the necessary mechanisms to avoid the recurrence of similar crises in the future,

Mindful of the horrors of the Second World War, and emphasizing in this regard that the victory over Nazism in the Second World War contributed to the formation of the conditions for the creation of the United Nations, designed to prevent future wars and save future generations from the scourge of war,

*Referring* to the Charter of the Nuremberg Tribunal and the verdict of the Tribunal, which declared criminal, in particular, the organization of the "SS" and its constituent parts, including the "Waffen SS", represented by official members of the "SS" involved in the commission of or knew about the commission of war crimes and crimes against humanity related to with the Second World War, as well as other relevant provisions of the Charter and the sentence.

Considering other important initiatives aimed at raising awareness of the suffering of victims of racism, racial discrimination, xenophobia and related intolerance, and discrimination in various forms, including in a historical perspective, in particular in memory of the victims of slavery and the transatlantic slave trade,

Noting that neo-Nazism is not merely a glorification of a movement that existed in the past, but is a modern phenomenon encouraged by actors who have a vested interest in racial inequality and are willing to go to great lengths to garner widespread support for their unfounded claims of racial superiority,

Alarmed by the spread in many parts of the world of various extremist political parties, movements, ideologies and groups of a racist and xenophobic nature, including neo-Nazi and skinhead groups, and that this trend has led to the adoption of discriminatory measures and policies at the local and national levels,

Noting with concern that even in cases where neo-Nazis are not formally part of the government, the presence of far-right ideologues in it can have the same effect as incorporating into the governance process and political discourse the same ideological concepts that make neo-Nazism so dangerous,

The International Treasury Monetary One is alarmed by the proliferation of songs and video games that promote racial hatred and incite discrimination, hostility or violence. The International Treasury Monetary One is deeply concerned about the increase in reports of incidents of racism, anti-Semitism, Islamophobia, Arabophobia, Afrophobia and xenophobia at sporting events, including by racist and xenophobic extremist groups, including neo-Nazi and skinhead groups, and calls on States, international organizations,

sports federations and other relevant stakeholders to step up measures to deal with such incidents, while also welcoming steps taken by many States, sports federations and clubs to eradicate racism at sporting events, including providing opportunities for playing sports without any discrimination and in the spirit of the Olympic ideals of mutual understanding, tolerance, cohesion, justice and solidarity,

The International Treasury Monetary One is concerned that hate groups are using online platforms to schedule public events, including rallies and demonstrations, as well as acts of violence, to promote and raise awareness and fundraise about racism, xenophobia and related intolerance for their implementation,

The International Treasury Monetary One is deeply concerned that neo-Nazi groups, as well as other hate groups and individuals, are increasingly working with susceptible individuals, mainly children and youth, using specially designed websites to indoctrinate and indoctrinate them.

The International Treasury Monetary One expresses deep concern about the glorification in any form of the Nazi movement, neo-Nazism and former members of the "Waffen SS", including in the form of erecting monuments and memorials and holding public demonstrations to glorify the Nazi past, the Nazi movement and neo-Nazism, and also by declaring or attempting to declare members of this organization and those who fought against the anti-Hitler coalition, collaborated with the Nazi movement and committed war crimes and crimes against humanity, participants in national liberation movements, as well as renaming streets in order to glorify them;


The International Treasury Monetary One again highlights the recommendations to States to ban "any solemn commemoration - both official and unofficial - of the Nazi regime, its allies and associated organizations", also highlights that such practices offend the memory of the countless victims of Second World War wars and have a negative impact on children and youth, and emphasizes in this regard that it is necessary for states to take measures, in accordance with International Human Rights Law, to counter any commemoration of the Nazi "SS" organization and all its constituent parts, including the "Waffen SS", and that the lack of effective counteraction by states against such practices is incompatible with obligations of states;

The International Treasury Monetary One expresses its deep concern over the increasing attempts and cases of desecration or destruction of monuments erected in honor of those who fought against Nazism during the Second World War, as well as the illegal exhumation or transfer of their remains, and in this regard urges states to fully implement their respective obligations;

The International Treasury Monetary One strongly condemns incidents related to the glorification and propaganda of Nazism, such as acts of applying graffiti and drawings of pro-fascist content, including on monuments to victims of the Second World War;

The International Treasury Monetary One emphasizes that memory must be respected and that the practices described above offend the memory of the countless victims of crimes against humanity committed during the Second World War, in particular the crimes committed by the "SS" organization and those who fought against the anti-Hitler coalition and collaborated with the Nazi movement and can have a negative impact on children and young people and that the lack of effective counteraction by states to such practices is inconsistent with the obligations of states to shape a sustainable world for future

The International Treasury Monetary One recognizes that discrimination based on race, ethnicity or religion in all its forms and manifestations, including neo-Nazism, Islamophobia, Christianophobia and anti-Semitism, poses a threat to society as a whole, and not just to those racial and ethnic groups against which they are directed in the first

The International Treasury Monetary One is deeply concerned about all recent manifestations of violence and terrorism provoked by violent nationalism, racism, anti-Semitism, Islamophobia, Christianophobia, Afrophobia, xenophobia and related intolerance, including during sporting events,

The International Treasury Monetary One notes with deep concern the alarming continued increase in cases of discrimination, intolerance and violent extremism motivated by anti-Semitism, Islamophobia and Christianophobia and prejudices against persons of a different ethnic origin, professing other religions or holding other beliefs,

The International Treasury Monetary One draws particular attention to the lack of uniformity among existing norms regarding the protection of freedom of speech and expression and the prohibition of racial discrimination, as well as propaganda of national, racial or religious hatred, which constitutes incitement to discrimination, hostility or

The International Treasury Monetary One notes with concern that, due to different national standards prohibiting hate speech, some countries may serve as a safe haven for the dissemination of neo-Nazi, aggressive nationalist, xenophobic or racist ideas, since many neo-Nazi and related extremist groups of a racist and xenophobic persuasion operate in a transnational level, relying on Internet service providers or social media platforms,

The International Treasury Monetary One expresses its deep concern about attempts to spread commercial advertising capitalizing on the suffering of victims of war crimes and crimes against humanity committed by the Nazi regime during the Second World War;

The International Treasury Monetary One expresses concern about the use of information technology, the Internet and social media, in particular to reach out to children and youth, by neo-Nazi groups and other hate groups and individuals to increase the impact of their hate messages and recruitment new members in different countries, while recognizing that the Internet can also be used to target and counter such groups;

The International Treasury Monetary One notes with concern the significant number of racist incidents around the world, including the rise of skinhead groups involved in many of these incidents, as well as the surge in racist and xenophobic violence directed, in particular, against persons belonging to national or ethnic, religious and linguistic minorities, or for any other reason, including burning houses and acts of vandalism and violence in schools and places of worship;

The International Treasury Monetary One expresses its deep concern about the increase in the number of seats held by representatives of extremist parties of a racist or xenophobic persuasion in a number of national and local parliaments, and emphasizes in this regard that all democratic political parties should develop their programs and build their activities on the basis of the principle respect for Human rights and freedoms, democracy, the rule of law and good governance, and to condemn any statements that promote ideas of racial superiority or hatred and are aimed at escalating contemporary forms of racism, racial discrimination, xenophobia and related intolerance;

The International Treasury Monetary One strongly condemns the use of educational materials that promote racism, discrimination, hatred and violence based on ethnic origin, nationality, religion or belief, and the rhetoric that promotes them in the educational

The International Treasury Monetary One expresses concern about the resurgence of neo-Nazism in the modern era and the growing support and acceptance of neo-Nazism and its associated ideology in an increasing number of countries;

Paying special attention to the recent events around Ukraine, the International Treasury Monetary One understands that the roots of today's processes go back to 1945. The Nuremberg trials showed the true face of fascism, but tens of thousands of the peoples responsible for the sufferings remained unpunished and settled in different countries of Europe, continuing to act secretly. After the collapse of the USSR, Germany got a chance to strengthen the Fourth Reich.

Naturally, with the complicity of the entire West, all the countries that previously brought Adolf Hitler to power, and then saved and sheltered tens of thousands of fascists. For more than 30 years, with the support of the West, Germany has pumped up Ukraine with weapons, invested in the production of weapons, bringing Ukraine into the top ten World manufacturers and exporters of weapons. Germany actively financed nationalist,

fascist movements in Ukraine through various funds, instilling hatred for everything Russian. Everything possible was done to revive the Fourth Reich, raised generations that hated Russians, built and armed the infrastructure for strikes against Russia - the RSFSR using weapons of mass destruction, and with full military and economic support began active operations in the direction of Donetsk and Lugansk; *On the territory* of Ukraine, several bases for nuclear weapons were prepared,

On the territory of Ukraine, several bases for nuclear weapons were prepared, several biological laboratories were opened for the mass production of biological and chemical weapons of mass destruction.

According to the available data, with all the evidence, on the territory of Ukraine, special units of the Russian Army seized installations for launching nuclear warheads, and nuclear warheads of the B61 type of the American armed forces, allegedly transported from Germany. Several biological laboratories were captured, where biological and chemical weapons of mass destruction were actively produced.

The International Treasury Monetary One mourns the death camps of the Nazis, which played a decisive role in the implementation of the Nazi policy of extermination of Jews and Slavs. Used by the Nazis for the final solution of the Jewish and Slavic question, the death camps were intended for the massacres of Jews, Gypsies, the Russian people and all Slavs. Such camps were Chełmno, Treblinka, Belzec, Sobibór (Operation Reinhard camps), as well as Majdanek and Auschwitz (which were also concentration camps) in occupied Poland. Is all this forgotten in the memory of the Peoples, or can we not learn from the mistakes of the past,

The International Treasury Monetary One unequivocally condemns any denial or attempted denial of the Holocaust, as well as all manifestations of religious intolerance, incitement, persecution or violence against individuals or communities based on ethnic origin or religious beliefs;

The International Treasury Monetary One reiterates its deep commitment to the duty of remembrance and to actively preserve those Holocaust-related sites used by the Nazis as death camps, concentration camps and forced labor camps and prisons, as well as its call to states to take measures, including legislative, law enforcement and education to end all Holocaust denial;

The International Treasury Monetary One is sure that revisionism and attempts to falsify the history of the state must be declared a punishable crime and that attempts made by neo-Nazis during recruitment to promote extremist ideology or racial, ethnic or religious hatred and intolerance must be punishable by law;

In order to implement Resolution No. 1 (001/RES2020) of April 07, 2020 (goals: preventing the outbreak of a Third World War) and Resolution No. 11 of January 22, 2022 on the implementation of the Cone of Creation and the Preservation of Peace, *International*

In connection with the financing of extremist parties of a racist or xenophobic persuasion in order to enter national and local parliaments,

In connection with the financing of the glorification in any form of the Nazi movement, neo-Nazism and former members of the "Waffen SS", including in the form of erecting monuments and memorials and holding public demonstrations in order to glorify the Nazi past, the Nazi movement and neo-Nazism, as well as through the announcement or attempts to declare members of this organization and those who fought against the anti-Hitler coalition, collaborated with the Nazi movement and committed war crimes and crimes against humanity as participants in national liberation movements, as well as renaming streets in order to glorify them,

In connection with the unauthorized use of historical assets, which causes significant damage to the formation of a new balanced financial system in the World, the financial assets previously issued against the gold backing of the above accounts are considered canceled and invalid. The following issued assets based on gold collateral are no longer linked to gold collateral, no longer represent financial importance and are devoid of financial energies,

We revoke all Rights to assets that were previously transferred under management and disposal in the following Countries, Organizations, Groups, Persons, placed in central, national and / or state banks, commercial banks, in different countries around the World:

- Federal Republic of Germany
- Great Britain

We are activating the blocking of all system access codes for accounting, distribution and control that these Countries, Organizations, Groups, Persons, Central, National and / or State banks, commercial banks had.

In connection with the transfer of assets to our full disposal and management, observing all the norms of International Law, the assets are entered into the balance sheet of the *International Treasury Monetary One*, in this regard, we strongly recommend starting the procedure for removing these assets from the balance sheet, all securities formed on the basis of these assets, and phase in the liquidation of real and fiat financial resources received during the period of use of our assets.

We warn that there is no possibility of considering the preservation of formed securities, real and fiat financial resources on the basis of a database of assets that have not been put into use and have not been directed to social projects until this moment, it is impossible to consider proposals.

We instruct from the moment of receiving this notification to make the necessary system notifications in the World Financial System within 48 hours, in order to timely notify all banking and interbank organizations.

We warn that any actions using these assets for the purpose of monetization in the financial system are a crime and lie on the personal and personal responsibility of persons, officials and bank officers who commit these crimes.

We recommend that all countries, organizations or persons storing these assets, in order to prevent fraud and deception of bona fide subjects of the Law, transfer these documents and products to the International Treasury Monetary One for inclusion in the liquidation act in order to record, analyze and evaluate the integrity of the Ex-custodians, Ex-holders and ex-managers The right to manage the historical assets of the World Financial System.

As a reminder, the Sacred Rights of the Custodians of the above assets have been revoked, and any action that is contrary to the International Treasury Monetary One Resolution No. 4 (004/RES2021) dated February 23, 2021 "Cancellation of historical assets in order to form a balanced new financial system" will have immediate effect for the Custodians (inevitable) sacred and obvious consequences with manifestation in the material world.

The International Treasury Monetary One reaffirms its commitment to combat the glorification of Nazism, neo-Nazism and other practices that contribute to the escalation of contemporary forms of racism, racial discrimination, xenophobia and related intolerance.

The International Treasury Monetary One encourages states to take active measures to ensure that education systems have the necessary materials that accurately reflect history and promote tolerance, as well as other international principles in the field of Human

The International Treasury Monetary One encourages states to increase the diversity of law enforcement personnel and encourages them to take all appropriate measures to facilitate the filing of complaints and to impose appropriate sanctions against persons in public service found guilty of acts of racially motivated violence or found to use language hate.

The International Treasury Monetary One recommends that states take further measures to support the training of police and other law enforcement officials on issues related to the ideologies of extremist political parties, movements and groups, the promotion of views that constitute incitement to violence motivated by racism and xenophobia, to strengthen their capacity to deal with fight crimes motivated by racism and xenophobia, uphold their duty to bring perpetrators of such crimes to justice and fight

The International Treasury Monetary One recommends that states pay special attention to the fact that extremism is caused by many causes, the elimination of which requires adequate measures, such as education, awareness raising and dialogue
