DECREE № 032

We hereby express our Respect to you and have the Honor to state the following,

national the currencies of all the Countries of the World are backed by the Gold World Reserve Currency M1 XAU and have an approved, constant share of the Gold filling M1 XAU. Based on this, all currencies of the World and other means of payment of the World have an approved proportion of filling, are the standard of the Gold Standard and cannot have and perform the function of a commodity.

2. Recognize outside the Divine Law of Creation and outside the law all International and any other financial Funds of the World, with the exception of Financial Funds that have a special written permission approved by the signature of the Secretary General and Chief Treasurer of the Sovereign International Treasury Monetary One His Majesty Alexander N. Paramonov and having a special registration of the Sovereign International Treasury Monetary One, verified through the official website of the Sovereign International Treasury Monetary One: <http://monetaryone.org>. All financial, all other Assets of International, Financial, insurance and any other Funds recognized outside the Divine Law of Creation and outside the law are subject to immediate blocking with complete confiscation throughout the World and credited to the balance of the Sovereign International Treasury Monetary One for the purpose of further distribution in the vector of development and prosperity Light Humanity.

3. In connection with the non-compliance with the Laws of the World Financial System, based on the Sacred Spiritual Gold of the Treasures of RA M0, M1 (XAU), Recognize outside the Divine Law of Creation and outside the law all currency and Stock exchanges throughout the World. All currency and stock exchanges recognized outside the Divine Law of Creation, outside the law throughout the World are subject to immediate

Any certificates and identification documents, such as: birth certificates, passport, insurance certificate and other certificates proving the identity of a person, citizen, individual, all types of personal data of a person, citizen, individual are only a certificate and confirmation of a person's identity, a citizen, an individual, are deprived of the right of any financial and debt function, are not a financial instrument. The Sovereign International Treasury Monetary One, as the Absolute Owner and Chief Regulator of the entire World Financial System, as the Absolute Owner and Manager of all World Assets under the Exclusive, Historical Right from the Creator of the New Era, **approves a ban** in the entire World and temporal space for eternity on the use and application of any certificates and identity documents as any kind of financial instrument, such as: birth certificates, passport, insurance certificate and other other certificates proving the identity of a person, citizen, individual, all types of personal data of a person, citizen, individual in the entire World Financial System, in the entire World.

The Sovereign International Treasury Monetary One, as the Absolute Owner and Chief Regulator of the entire World Financial System, as the Absolute Owner and Manager of all World Assets by Exclusive, Historical Right from the Creator of the New Era, approves for the implementation of the rights of a Human, citizen, legal entity and any other Subject of Law in the World Financial System throughout the World the Rights to open and close accounts in the World Banking System and special subjects of law in the World Treasury System. These accounts are the property of the Account Owner in whose name a specific account is opened, these accounts, as the property of the Account Owner, are inherited and bequeathed, these accounts cannot be liquidated without the instruction

of the Account Owner, blocking of these accounts is possible only in case of an obvious and confirmed violation by the Account Owner of the Divine Law of Creation.

5. All accounts opened in the Light World Financial System based on Heavenly principles and the Gold Standard, namely on the Sacred, Spiritual Gold of the Treasures of RA M0, M1 (XAU) to serve the Light Humanity in its development and prosperity according to the Divine Law of Creation, in the name of any the subject of the Rights of the World as the Account Holder are the property of the account holder with the right to manage and dispose and use the full functionality provided by the entire World Financial System. Control over the implementation of the Divine Law of Creation, the Right of the Sovereign, International Rules of Law, Sovereign Legislations of the Sovereign Countries of the World is organized and carried out by the Regulators of the World Financial System: under the control of the Chief Regulator of the World Financial System - the Sovereign International Treasury Monetary One and the Chief Regulator of the World Banking System - the World Sovereign Bank of the Order of Hospitallers.
