Order

1. 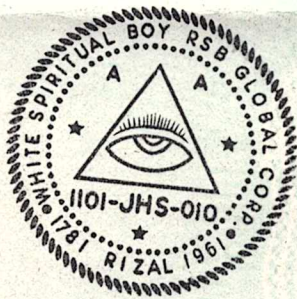
