2. To the World Sovereign Bank of the Order of Hospitallers, issue and register the Gold Backed Crypto Currency CryptoXau (AXM) in the amount of 1,000,000,000.00 (One billion) CryptoXau (AXM).

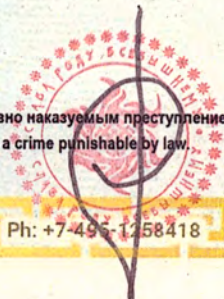
